Neighborhood Construction Update Meeting – West Linn

I. Discussion, brainstorm and topics of interest

Responses provided at the meeting are shown in *italic*.

1. What is the plastic pipe that is staged along the side of Highway 43 near Old River Road?
Khameese said the pipe is being used to chlorinate and disinfect the new pipeline on Highway 43 and at the Old River Road pump station, where there is a connection to West Linn's system.
2. Where do the double dump trucks go when they are traveling east along Mapleton Drive? How do they exit the neighborhood?
Ray said that it is determined on a day-to-day basis. Lately, Coluccio has been coordinating with Slayden to try to have the trucks exit through the plant site, however, this is dependent on day-to-day activities at the site. Ray mentioned that later when open-cut work starts, they will need to turnaround trucks on Mapleton in wider locations, using the right-of-way.
3. When is your projected start date for open-cut pipeline work on Mapleton Drive?
Ray stated that at this stage, it is looking like mid-July.
4. The new plantings at the HDD site look like they are not surviving in the heat. Are you irrigating them?
Ray said, up until now, they have been using a water truck and watering twice a day, but they will be putting a temporary irrigation system in soon and keeping them watered through the summer.
5. Compliment to the flaggers on Mapleton Drive – they have been fantastic so far.
Ray thanked the attendee for the compliment.
6. There is dust and dirt on the street (Kenthorpe), please do your best to clean it up during the dry weather.
Ted stated that Slayden has the street sweeper on site and uses it as needed, particularly when they are hauling during large excavations.
